constitutes agreement by the entrant to the
Rules and Regulations set forth in this application.*

- 1. A \$25 penalty fee will be withheld for a participant's
withdrawal before August 15. No refund will be made for
withdrawal after August 15.*
- 2. Food concessions must remain open with adequate food stock
during Fair hours. We estimate having 5—6,000 visitors over
the two days, but momentum is growing fast for this event, so it
could be more. (5684 in for 2010)*
- 3. There are no rain dates and no refunds in the event of
inclement weather.*
- 4. Vendor will provide all equipment necessary for food service.*
- 5. Soft drinks and water may NOT be sold by Food Vendors.
Other specialty beverages (non-alcoholic meads and ciders, for
example) will be considered on a case-by-case basis.*
- 6. Acceptance will be based on selection of food items to be
sold, compliance with the Environment Dept. regulations, and
electrical and space needs.*
- 7. In keeping with the Fair's theme, costumes and
booth decorations are REQUIRED.
A list of suggestions will be provided upon request.*
- 8. The Fair reserves the right to limit duplication of food items.*
- 9. Vendors are responsible for keeping the area around their
trailer or booth clean.
Vendors must use dumpsters for trash disposal
- NOT the public trash barrels.*
- 10. Neither Open Hands nor Las Golondrinas will be
held liable for damage or theft.*
- 11. Participants not abiding by the rules and regulations will be
dropped from the mailing list.*
- 12. All food vendors must obtain a Temporary Food
Service Permit from the NM Environment Department
